How do we store your data?

Our Company will strictly manage your data and strive for preventive measures and safety measures against unauthorized access, loss, destruction, falsification, leakage, etc. as follows.

1. Maintenance of company regulations

We will establish rules regarding the handling of personal information.

2. Development of organizational structure

A person in charge of clerical work will be appointed to check the operational status and respond to information leakage cases and complaints.

3. Implementation of education and training

We provide regular education and training to employees regarding the safety management of personal information.

4. Implementation of physical safety management measures

In order to prevent theft and loss of devices and electronic media, we will take physical safety measures regarding their use and disposal.

5. Implementation of technical safety management measures

We will take technical safety measures to prevent unauthorized access.

Our Company will keep your personal data based on contracts, etc. with the person as a party for one year from the date of the last provision of personal data related to the record. At the end of this period, personal data on paper media will be shredded and deleted by a shredder, and personal data on electronic media will be deleted by erasing.

If we provide personal data continuously or repeatedly, we will keep it until the day when three years have passed from the date when the personal data related to the record was last provided. At the end of this period, personal data on paper media will be shredded and deleted by a shredder, and personal data on electronic media will be deleted by erasing.

In cases other than the above, we will keep the record for 3 years from the date of creation of the record. At the end of this period, personal data on paper media will be shredded and deleted by a shredder, and personal data on electronic media will be deleted by erasing.
